



**CITIZEN PATROL PSA
REQUEST FORM**

As an authorized member of the below listed Law Enforcement Agency, I am requesting for use by our department a copy of the NACOP 30-second Citizen Patrol Public Service Ad video and Audio Track. I understand that by submitting this request, we are bound to the below terms and conditions:

- 1) I understand this request is a "Right To Use" and not a purchase and the ultimate ownership of the video and Audio Track remains with the NACOP. Further our "right to use" may be terminated should the PSA be used or modified outside the scope of this agreement as listed below or in a manner not intended.
- 2) I understand the Citizen Patrol PSA was developed to help recruit and/or publicize our new or existing Volunteer group within our community and/or agency and will be used for those purposes.
- 3) To assist Law Enforcement agencies in their recruiting and/or publicizing efforts, the requested PSA Video has been edited in two formats. The first format on the video tape ends with a three second still shot of the National Association Citizens On Patrol name, logo and the following statement:

Produced by the National Association Citizens On Patrol
This project was supported by Award No. 2003-00-BX-0037 awarded by the
Bureau of Justice Assistance, Office of Justice Programs.

The second 30-second format included on the video ends with a three second still shot of the above, minus the NACOP logo. Requesting agencies are authorized, at their expense, to add their own logo, name, phone number and or other information that will provide the viewer with the information necessary to directly contact them in this blank space. However, the statement "Produced by the National Association Citizens On Patrol. This project was supported by Award No. 2003-00-BX-0037 awarded by the Bureau of Justice Assistance, Office of Justice Programs" may Not be removed and must be left as is. With regards to the PSA audio track, agencies may add to the end of the PSA audio track, for radio station air play, information necessary for listeners to contact your agency such as name, phone number, etc., if so desired.

- 4) I understand that under no circumstances will our agency modify, edit, include and/or otherwise make changes to this video or audio track other than as allowed for in item 3 above.
- 5) I understand our agency may duplicate this tape and CD to distribute internally and/or for submission to additional broadcast, TV, Cable, etc., stations within our community; however distribution to others outside of our agency is not permitted and doing so would result in the termination of this "Right to Use" agreement.
- 6) The PSA was developed and funded specifically for use by valid Law Enforcement and Citizen Patrol groups. The NACOP reserves the right to deny requests for this PSA to any group it believes does not meet the criteria of a Law Enforcement Volunteer or Citizen Patrol group for which the PSA was intended.
